## THE INFORMATION COMPANY COLLECTS, USES and SHARES

### Collection of Personal Data

We may collect the following categories of personal data:

- Identifiers (e.g., name)
- Contact information (e.g., telephone number, email address, physical address)
- Protected classification information (e.g., age, race, gender, physical or mental disability, sexual orientation, marital status)
- Commercial information (e.g., products or services purchased)
- Internet and network information (e.g., internet protocol address, information about a consumer's interaction with our website)
- Geolocation data
- Inferences drawn from the categories of information identified here
- Sensitive personal information

We obtain the above categories of information from the following sources:

- From you when you directly or indirectly interact with us and provide us the data
- From your activities on our Website and through the use of cookies
- From social networks
- From public records
- From service providers
- From business partners

## Use of Personal Data

We may use your personal data for any of the following purposes:

- To provide, maintain, and improve our products and services
- To communicate with you
- To provide you with information, products, and services that you request from us
- To conduct market and consumer studies
- To personalize, advertise, and market our services
- To evaluate your eligibility for funding programs
- To process payments or verify your financial or insurance data
- To report and investigate adverse events
- To detect, investigate, prevent, and respond to fraud or any other harmful activities
- To comply with our legal and contractual obligations
- To exercise and defend legal claims
- To otherwise operate our business
- As described to you at the point of data collection or handling or otherwise where we are legally permitted or are required to do so

Data that is in an aggregated or deidentified form is not personal data. We may share deidentified data.

## Sharing of data

**We do not share or sell your personal data.** We will not disclose or transfer your personal data to any third party except when one of the following is true:

- You consent to the disclosure
- The disclosure is to a party that controls, is controlled by, or is under common control with us
- The disclosure is related to a business purpose
- The disclosure is reasonably necessary for the establishment or maintenance of legal claims
- The disclosure is required by law
- The disclosure is reasonably related to the sale or other disposition of all or part of our business or assets
- The disclosure is not inconsistent with this Privacy Policy or our description at the point of collection or handling, and otherwise not prohibited by applicable law

When we disclose personal data for a business purpose, we enter a contract with the recipient that describes the purpose for handling the data and requires the recipient to keep them secure and confidential and not use them for any purpose except performing the contract. We have disclosed the following categories of data for a business purpose:

## OUR COMMITMENT TO CHILDREN'S PRIVACY

We follow generally accepted industry standards to safeguard your information, however, no data or email transmission is ever fully secure or error free. Therefore, please take special care in deciding what information to send us. We have reasonable safeguards in place to protect your information, and we have taken the following security measures:

- **Transport Layer Security (TLS)** - We use TLS encryption when transmitting certain kinds of information through the App from your mobile device to the Company server. An icon resembling a padlock is displayed in most browsers during TLS sessions. We also encrypt information you provide to us when information is **at rest and stored** in our servers. When you send text messages or emails to your friends, family or other individuals in your contact list, those messages or emails are outside of our control and are not encrypted. Alerts and reminders sent to your mobile device are also not encrypted.
- **Secure Storage** - We deploy reasonable and appropriate industry standard physical, technical, and administrative safeguards to protect your personal information.
- **Vendors and Partners** - To protect the security and privacy of your information, we may provide information to partners and vendors who work on our behalf or with us and require them to agree to maintain the confidentiality of your information.
- **Access to Information** - We limit access to your Personally Identifiable Information to those employees who reasonably need access to such information in order to provide you with services and process your information appropriately.

## IN THE EVENT OF MERGER OR SALE

In the event that Company is acquired by or merged with a third-party entity, we reserve the right, in any of these circumstances, to transfer or assign the information that we have collected from Users as part of such merger, acquisition, sale, or other change of control.

## YOUR CHOICES

You may decline to provide any Personally Identifiable Information to us while visiting and using our Site. ## COMPANY COOKIE POLICY

We use cookies to understand how Users engage with our Site. This Cookie Policy is part of our Privacy Policy and covers the use of cookies between your device and our Site.

### What are cookies?

Cookies are small pieces of data, stored in text files that are stored on your computer or other device. Cookies may be set by the site that you are visiting, or by third parties, such as those who serve content or provide advertising or social media integration services on the website (known as “third party cookies”). The website or third party that sets the cookie may access the cookie on subsequent visits. This enables websites to “remember” you and your preferences, either for a single visit (through a “session cookie”) or for multiple repeat visits (through a “persistent cookie”). Cookies help ensure a consistent and efficient experience for visitors, and perform essential functions such as allowing users to register and remain logged in.

Both websites and emails may contain other tracking technologies such as “web beacons” or “pixels.” These are typically small transparent images that allow us to gather information for similar purposes as cookies. Web beacons or pixels are often used in conjunction with cookies but are not stored on your computer in the same way. As a result, if you disable cookies, web beacons may still load, but their functionality will be restricted.

### How do we use cookies?

We use web analysis tools such as Google Analytics, Google Adwords and Microsoft Ads. Such tools may use cookies to collect Non-Personally Identifiable Information. Cookies are small bits of information cached or stored on a computer, mobile or other device of a User for record keeping purposes. Cookies may be used for many purposes, including, but not limited to, remembering you and your preferences and tracking your usage in order to improve the service. Cookies themselves do not typically contain any Personally Identifiable Information. We may analyze the information derived from these cookies and other technological tools we employ to make improvements and in keeping with observed User preferences. They allow us to remember useful information which allows certain functionality within our Site to work, for example, remembering if you’ve logged in.

### Types of Cookies

Strictly Necessary Cookies. These cookies are used to make sure our Site works and that you can use them effectively, such as remembering certain information on a form when you go to another page before the form has been completed. These cookies are used to remember information you’ve entered on our forms when you navigate to different pages in a single web browser session using our Site. These cookies are not used to gather information that could be used to advertise products or services to you, or to remember

any preferences you have set beyond the current visit. If you prevent these cookies you may not be able to use certain features on our Site.

Performance Cookies. These cookies are used to measure the performance of our Site, improve how our Site work, and measure our marketing activity. Information that is collected using these cookies is aggregated and anonymous and we are not able to identify individual users. We may use these cookies to provide aggregated statistics on how our website is used, see how effective our marketing activity is, and provide feedback to partners that one of our visitors also visited their website. We may also use these cookies to measure any errors that occur, improve the performance of our Site, and test different page designs on our Site. We do not use these cookies to target you with advertising on other websites, or to remember any preferences you have set beyond the current visit.

Functionality Cookies. These cookies allow websites to remember choices you make (for example, your user name, language or the region you are in) and provide enhanced, more personal features. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can modify. They may also be used to provide services on the site such as watching a video. We use these cookies to remember settings you've applied such as layout and text size, and remember if you have already completed an online survey. We do not use these cookies to target you with advertising or track your browsing activity on other websites.
